Oprávnenia zamestnávateľa

Zamestnávateľ môže:

- testovať na pracovisku (so súhlasom)
- vyslať zamestnanca na služobnú cestu (podľa ZP) a znášať náklady na testovanie pre príjazd do danej krajiny
- vyžadovať prekrytie horných dýchacích ciest v súlade s vyhláškou o protiepidemiologických opatreniach
- požadovať informácie o COVID-19 zaočkovaní od iných osôb ako zamestnancov pri ich vstupe na pracovisko

Zamestnávateľ nemôže:

- požadovať informácie o COVID-19 zaočkovaní
- nariadiť COVID-19 očkovanie
- uložiť zamestnancovi povinnosť testovania
- požadovať informácie o výsledkoch testov
- zamestnancom nezaočkovaným proti COVID-19 nemôže zabrániť vo vstupe na pracovisko, odmietnuť prideliť prácu, nariadiť plnenie iných pracovných úloh

Novela Zákonníka práce v legislatívnom procese

- plánovaná účinnosť od 1.8.2022
- cieľ novely: transparentné a predvídateľné prac. podmienky, rovnováha medzi pracovným a súkromným životom
- nové informačné povinnosti a spôsoby poskytovania informácií o podmienkach práce (aj elektronicky)
- právo zamestnanca žiadať prechod na inú formu zamestnania (napr. z určitej doby na neurčitú, z kratšieho p. času na ustanovený týždenný p. čas)
- otcovská dovolenka
- úložná lehota zásielky (10 dní)

The 2021 amendment to the Slovak Labour Code

Most of the changes concerning working at home, meal allowance, and trade union activities will come into force on 1 March 2022. One change, namely the one allowing dismissal due to retirement age, will not take effect until 1 January 2022 or 1 January 2023.

The amendment to the Labour Code addresses several issues that both employees and employers have struggled with in practice. In the following, we provide a review of the most important changes, recommendations on how to implement them, and warnings about some practical details that the amendment has not resolved.



Application for extension or amendment of a decision issued under the Slovak Act on Waste

With effect from 1 July 2021, applications for the issue of a decision, extension of the validity of a decision, or an application for amendment of a decision issued under the Slovak Act on Waste are to be submitted electronically through the so-called Waste Management Information System (ISOH).

It is still unknown whether the ISOH will technically allow the submission of such applications on 1 July itself. If not, applications will continue to be submitted via the portal www.slovensko.sk.
